**Subject: Indecent Exposure Suspect Attacks Deputy during Arrest**

On Tuesday, October 22, 2013, shortly after 6:00 p.m., Yolo County deputies responded to a report of a male exposing himself in the 25000 block of Clover Street in Esparto.

When the first deputy arrived on scene he observed a male standing in front of the residence. The deputy began asking the male if he was okay. The male, later identified as Pierre Lumsey, age 29 of Esparto, began screaming and yelling profanities at the deputy and then walked into the residence.

Lumsey then came back outside and that's when the deputy noticed the subject again had his pants pulled down, partially exposing himself.

As the deputy approached, Lumsey turned and tried to run back into the residence. When the deputy attempted to grab Lumsey, the subject turned and attacked the deputy, punching the deputy in the face. After a considerable struggle, Lumsey broke free, tried unsuccessfully to grab the deputy's Taser and then ran into the residence. The deputy then radioed for additional assistance.

Minutes later, additional deputies arrived on scene, as did an officer from the California Highway Patrol who was in the area.

As the deputies entered the residence to arrest the subject, Lumsey ran through the house and into the garage. As Lumsey was running toward deputies, the CHP officer fires four bean bag rounds from his less lethal weapon, which had little effect on Lumsey. Deputies then were successful in taking Lumsey to the ground, where a lengthy struggle ensued before the deputies were finally able to take Lumsey into custody.

***"Service Without Limitations"***

Lumsey was arrested for Battery on a Peace Officer, Indecent Exposure and Resisting Arrest, and transported to the Monroe Detention Center for booking. Bail has been set at \$50,000. Lumsey is scheduled to be arraigned at the Yolo County Superior Court Friday, October 25, 2013
